## TEXT MESSAGING

Visit [www.jailfunds.com](http://www.jailfunds.com). Follow the prompts to locate inmate. Send message. Messages sent to the inmate are free. If an inmate responds or initiates a message, they are charged \$0.55.

## VIDEO VISITATION

Inmates can receive one 15 minute video visitation per day. You will schedule your visit not less than six days before the day it is to take place. All visitations must be approved by the HCSO. If for some reason your scheduled visit has to be cancelled, your money will be refunded in full. The cost to you is \$5.70 for 15 minutes and you must be on the inmate's approved visitor list.

You can visit our main facility at 10451 Larkin Smith Drive, Gulfport, MS to visit with an inmate via video at no charge. However you still have to register your visit on [www.jailfunds.com](http://www.jailfunds.com) and select the option for on-site visitation. Video kiosks are located in our main lobby for this use.
